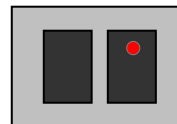

Flash pattern selection :

Push the button in the **Left**, less than 1 second for next pattern, 1 to 3 seconds for previous pattern, More than 3 seconds return to the pattern 25.

Magnet-mounted beacon: To maintain durability of the suction pad, always use release mechanism located on the outer ring when removing beacon from the vehicle.

Remark:

1. half side by side.
2. Crisscrossed
3. 0~3 sec full light, 3~16 sec decrease intensity from 100% to 40%.
